Minutes of the Regular Meeting of the Board of Trustees

Monday, November 19, 2012

A regular meeting of the Cuyahoga Arts & Culture (CAC) Board of Trustees was called to order at 4:01 p.m. in the Museum of Contemporary Art Cleveland (MOCA), Cleveland, Ohio.

The roll call showed that Trustees Sari Feldman, Vickie Johnson, Matt Charboneau, and Steven Minter were present. It was determined that there was a quorum.

Also in attendance were: CAC staff: Karen Gahl-Mills, executive director, Jill Paulsen, director of grant programs, Meg Harris, director of administration; Jennifer Schlosser, communications manager, Stacey Hoffman and Jesse Hernandez, program managers and Jake Sinatra, program associate.

1. <u>APPROVAL OF MINUTES</u>

2. EXECUTIVE DIRECTOR'S REPORT

Ms. Gahl-Mills welcomed meeting attendees and thanked MOCA Cleveland for hosting today's meeting. Ms. Gahl-Mills introduced Jill Snyder, Executive Director of Museum of Contemporary Art Cleveland. Ms. Snyder provided a summary of the activities taking place at MOCA Cleveland.

Ms. Gahl-Mills stated that during the meeting, CAC staff would ask the Board to approve the recommended grants for 2013 Project Support and 2013-14 General Operating Support, and made other comments.

Ms. Harris gave a report on CAC's finances.

(Trustee Coburn arrived at 4:10 p.m.)

3. BOARD ACTION

Approval of panelist roster for Creative Culture Grants Program

Approval of 2013 Grant Scores, Allocations and Grant Awards

Ms. Paulsen provided an overview of the 2013 Project Support and 2013-14 General Operating Support grant programs. She stated that, with the Board's approval, in 2013:

- Participation in CAC's grant programs is growing;
- CAC grants will support organizations of all sizes and disciplines; and
- CAC-funded organizations will serve residents throughout Cuyahoga County.

Project Support 2013

Ms. Paulsen and Ms. Hoffman presented an overview of the Project Support 2013 Grant Program Memo (attached), provided to the Board in advance of this meeting.

Approval of 2013 Project Support panel scores;

A representative from Shaker Historical Society asked about CAC's process – how does CAC provide meaningful grants to small organizations versus medium or large ones? Ms. Gahl-Mills stated that the

General Operating Support and Project Support programs provide two opportunities for grants, and that CAC's grant process judges everyone based on the same criteria, rewarding vibrancy, public benefit and other factors regardless of size, so that every organization can successfully achieve a meaningful grant.

Executive Director's Report Regular Meeting of the Board of Trustees 10 December 2012 (amended)

Today's meeting is centered primarily on one strategic issue: the approval of the 2013 operating budget.

Our operating budget brings our priorities to life for the coming year. With it, we make concrete our plans for the future by putting resources behind our objectives. (Our team's objectives for 2013 follow this memo.)

You'll notice that we have, once again, allocated more resources toward programs than in prior years, even at a time of shrinking revenues. We have, once again, efficiently allocated our administrative expenses such that we will have what we need to carry out our work. And we have made provision for some new work, specifically through a proposed contract with Neighborhood Connections, that will allow us to bring our vision of neighborhood-based grantmaking better into focus.

One might ask why we are proposing a budget in which it appears, at first glance, that expenses exceed revenues. After all, we actually provide financial incentives for our cultural partners to do just the opposite. Why, then, do we not seemingly play by our own rules?

Recall that CAC was forward funded and so has an operating reserve on its books specifically designated for funding current operations and future grant programs. In fact, that operating reserve that has grown by over \$1.3million since 2010 thanks to sound fiscal management by our team. So it is more appropriate to say that, in 2013, our expenses will be financed by current tax revenues and transfers from our operating reserve. The budget before you will be balanced, represents an appropriate level of fiscal discipline, and is aligned with CAC's <u>spending policy</u>, and I look forward to discussing it with you during our meeting.

Also in the materials for today's meeting, you will find:

- ⇒ A recommendation for an agreement with Neighborhood Connections for 2013, representing a pilot, neighborhood-based grantmaking strategy in Cleveland and East Cleveland that aims to grow our footprint with arts and culture activity that we are not currently reaching;
- ⇒ An update on our grant program activity post-award announcement, including a snapshot of a current PS partner, TOPS Swingband;
- ⇒ Details about CAC's efforts in the community and how we are leveraging social and traditional media to get the word out about our work; and
- \Rightarrow Our YTD financial results.

Thank you, as always, for your thoughtful attention to the matters before the Board. Best wishes to you and yours for a happy and healthy holiday season.



Team Objectives for 2013

Mindful of the <u>agreements</u> that we have made with one another, and grounded by CAC's <u>Mission</u>, <u>Vision & Values</u>, we state the following objectives for 2013:

Grantmaking & Knowledge-Building

- Convene partner organizations in ways that encourage information sharing, highlights collaborations, and seeks linkages that address issues of common cause.


Raising Awareness


- Communicate impact of CAC funding to stakeholders and County residents, reaching beyond the cultural community to the community at large.

- Support team learning and development, both individual team members and team as a whole.



CAC Board Meeting December 10, 2012 Updates from Staff

1. FINANCIAL REPORT YTD

Revenue

Tax revenue was \$15,475,358 as of November 30, 2012. This figure is \$661,598 above forecast year-to-date. Revenue continues to decline year-over-year with collections down 1.15% compared to the same period in 2011.

Interest revenue through November was \$29,828. This figure exceeds our forecast by \$11,828. The investment of \$13million in STAR Plus has yielded \$3,202 over the past five weeks.

CAC inactive monies are currently invested in the following:

- o STAR Plus- \$13,003,202 (yield .25%)
- Baird Public Investment Advisors \$8,009,662 (target yield .35%)
- o STAR Ohio- \$1,831,000 (yield .10%)

Expenditure

Expenditures through November were \$14,545,648. This figure is approximately \$356,000 under budget year to date and is due primarily to the timing of payments, particularly in the area of grant payments.

Audit/Finance Committee

The audit and finance committee met on November 14, 2012. At this meeting, the committee reviewed the proposed changes to the Internal Financial Control Policies and Procedures for CAC. Committee members offered recommendations to the proposed revisions and further recommended that the Board adopt the revised policy at the December 10 meeting.

At the December meeting we will also present a Capitalization, Depreciation and Retirement of Property and Equipment Policy to the Board for approval. This policy details which assets shall be capitalized and therefore depreciated and which may be expensed. Currently CAC has a \$500 capitalization threshold. The new policy proposes raising that threshold to \$2,000.

2. HUMAN RESOURCES

Over the past several months, CAC has been working with legal counsel to add and/or revise several personnel policies for inclusion in CAC's Employee Manual. These changes, all of which were written and/or reviewed by legal counsel, are detailed in a memo provided to the Board with this month's meeting materials. Additionally, the Board will be asked to approve a resolution that relates to CAC's Flexible Spending Account (FSA) Plan. Due to changes mandated by the Affordable Care Act, the contribution threshold for out-of-pocket medical expenses will be reduced to \$2,500. Board action is required on this item.

Additionally, in 2013, we will switch our medical coverage from Anthem to Medical Mutual. We have received a quote from Medical Mutual, via our COSE membership, which reduces the cost of our medical coverage by approximately 11% or \$3500 per year. Additionally, the coverage offered through Medical Mutual is more favorable for participants than our current plan. Finally, by moving to a new health plan effective January 1, we are able to move to a renewal cycle that matches our fiscal year and allows for better budget planning.

3. CREATIVE CULTURE GRANTS

The Creative Culture Grants program was officially opened to eligible lead applicants via a notification email sent November 1. A follow-up message was sent November 29, reminding eligible lead applicants of the December 13 deadline. CAC has fielded multiple calls from cultural partners and the general public concerning the grant program and possible projects, and has also met with a few eligible lead applicants to discuss their projects. As of November 29, five organizations had begun their application in CAC's online system, and CAC expects additional applications based on inquiries and conversations with groups.

4. CAC IN THE COMMUNITY

Arts and Culture Roundtable with County Executive Ed FitzGerald. On November 20, CAC, together with the Community Partnership for Arts and Culture, hosted an Arts and Culture Roundtable event featuring County Executive Ed FitzGerald. The event was held at the Idea Center's Westfield Insurance Studio Theatre in PlayhouseSquare, and was hosted by ideastream's Dee Perry.

Mr. FitzGerald spoke on the importance of the arts and culture sector to Cuyahoga County's economy, and took questions from the audience of more than 100 representatives from the arts and culture community. In December, ideastream will broadcast the program in its entirety on The Ohio Channel, which airs in households all over the State of Ohio. We will be sure to let board members know once we know once it is scheduled.

Post-Panel Site Visits. Following the announcement of the 2013-14 General Operating Support scores and awards, CAC has actively reached out to organizations to offer consultations on the context of scores and the review process. Meetings are held at the spaces and offices of cultural partners when possible, allowing CAC staff to utilize the meetings as site visits and gain a deeper understanding of the work being accomplished by the organizations. To date, 16 organizations have or are scheduled to meet with CAC staff before the end of the year.

Post-Panel Technical Assistance. CAC will offer four small-group workshops to review and discuss the grant agreement, disbursement of funds, reporting requirements and publicity requirements of the Project Support program during the weeks of December 3 and 10. Staff will share resources with cultural partners and seek feedback about how CAC can help the organizations be successful in the upcoming year. While the workshops are not mandatory, staff encourages first-time grant recipients to attend.

Cultural Partner Collaborations. CAC staff had the opportunity to observe the Cleveland TOPS (Tough Old Pros) Swingband perform in late November at Trinity Cathedral. The performance was part of the Brownbag Lunch Concert Series (a CAC-funded program) put on by Music and Art at Trinity. We were pleased to see the collaboration between two Project Support recipients. The concert drew a standing-room only crowd.

Looking ahead to 2013, CAC will continue to encourage cultural partners to work together – just as TOPS and Trinity are doing. We will do so by bringing cultural partners together at trainings and workshops so they can learn from one another and discover ways to partner together in the future.
