

# Minutes of the Regular Meeting of the Board of Trustees Monday, November 14, 2016

A meeting of the Cuyahoga Arts & Culture (CAC) Board of Trustees was called to order at 4:15 pm at the Mandel Jewish Community Center, 26001 South Woodland Road, Beachwood, OH 44122.

The roll call showed that Trustees Gwendolyn Garth, Joe Gibbons, Steve Minter and Charna Sherman were present. It was determined that there was a quorum.

Also in attendance were: CAC staff: Karen Gahl-Mills, executive director; Jill Paulsen, deputy director; Roshi Ahmadian; Meg Harris; Jessica Kayse; Dan McLaughlin; Jake Sinatra and Nicole Thomas.

County Executive Armond Budish made welcoming remarks.

Trustee Mark Avsec arrived at 4:21 pm.

#### 1. APPROVAL OF MINUTES

Motion by Trustee Minter, seconded by Trustee Avsec, to approve the minutes from the September 12, 2016 and November 3, 2016 Board meetings. Discussion: None. Vote: all ayes. The motion carried.

#### 2. PUBLIC COMMENT ON MEETING AGENDA ITEMS

Dominic Moore-Dunson (Inlet Dance Theater), Bill Wade (Inlet Dance Theater), Sean Watterson (Community Partnership for Arts and Culture), Jimmy Kuehnle (Cuyahoga County resident) and Lenora Brown (Cuyahoga County resident) made comments about funding for artists, including CAC's proposed partnership with National Arts Strategies and past partnership with Community Partnership for Arts and Culture.

#### 3. EXECUTIVE DIRECTOR'S REPORT

Ms. Gahl-Mills thanked the County Executive, Armond Budish, for his remarks, and the Mandel Jewish Community Center for hosting our meeting. Ms. Gahl-Mills shared a brief update on CAC's organizational planning process and how it has informed the agency's recommendation for a new direction to support artists in 2017. Lastly, Ms. Gahl-Mills acknowledged the more than 200 organizations recommended to receive grants and affirmed CAC's support for arts and cultural organizations and projects in the coming year.

#### 4. CONNECT WITH CULTURE

Mr. McLaughlin introduced Ms. Heather Ross-Lowenstein, past chair of the Jewish FilmFest, who offered remarks about the value of support from Cuyahoga Arts & Culture, including how support from CAC has helped the film festival to expand to reach new audiences and bring the community together.

#### 5. FINANCE REPORT

Ms. Harris gave a report on Cuyahoga Arts & Culture's finances. She provided an overview of the organization's financial results year-to-date, stating that revenue through October 31 was \$12,409,179. This figure is \$124,179 (1.01%) above forecast for the first 10 months of the year and 5.23% below revenue for the same period in 2015. Ms. Harris stated that CAC's investment income through October was \$177,912 which exceeded forecast by \$77,912. Ms. Harris stated that year-to-date cash expenditures were \$13,860,304 which is slightly under budget for the period and primarily related to the timing of grant payments.

Ms. Harris stated that the Board had received a memo that outlined the elements of the 2017 budget which will be presented to the Board for approval at the December 12 meeting. She noted that the proposed 2017 budget will include an increased recommendation for expenditures – specifically tied to additional arts and culture investments focused on experimenting with new programs that are a result of our community listening.

#### 6. DISCUSSION – Artist Funding

Ms. Paulsen shared a brief overview of the recommendation for a 2017-18 Creative Community Fellowship, in partnership with National Arts Strategies. The Board engaged in questions and discussions.

Trustee Garth asked whether it was possible to train an entity local to Cuyahoga County to take on the facilitation of grants to artists.

Trustee Avsec asked about the administration cost of the proposed program compared to prior years.

Trustee Sherman expressed support and excitement for CAC's new direction.

Trustee Minter asked for more details on the shortcomings of the current program.

Trustee Gibbons asked CAC staff to explain why it is proposing to work with National Arts Strategies specifically.
