Minutes of the Regular Meeting of the Board of Trustees

Wednesday, November 15, 2023

A regular meeting of the Cuyahoga Arts & Culture (CAC) Board of Trustees was called to order at 4:02 p.m. at Cleveland Public Library, Main Branch, Louis Stokes Wing, 2nd Floor.

The roll call showed that Trustees Blakemore, Isenhart, Mendez, Scott Taylor, and Sherman were present. It was determined that there was a quorum.

Also in attendance were Executive Director Jill Paulsen and CAC staff.

President Mendez welcomed the audience and said that today's meeting is where the Board approves 2024 grants for General Operating Support, Project Support, and Cultural Heritage programs. She added that grantmaking to nonprofits is precisely what CAC was designed to do and that CAC wants to celebrate the hard work of the 300 organizations recommended for grants today.

President Mendez acknowledged that today's meeting is happening at a difficult time for our arts community. She acknowledged that there are differing opinions on how future levy funding should be allocated and that some artists do not feel heard. She added that there is now uncertainty about when a potential campaign for expanded public funding can even take place. She said that CAC takes these issues seriously. CAC knows there is work to be done to build trusting relationships that will allow our sector to move forward in a healthy manner. She noted that we have been working on this. And we'll continue to do so.

1. APPROVAL OF MINUTES

Motion by Trustee Scott Taylor, seconded by Trustee Isenhart, to approve the minutes from the September 13, 2023 meeting, with the recommended correction (below) made by Trustee Sherman.

Discussion: Trustee Sherman stated that the minutes should be corrected, under the discussion of the action to approve the personnel report, to change the word "how" to "what".

3. EXECUTIVE DIRECTOR'S REPORT

Director Paulsen thanked everyone for joining her and the Board. Ms. Paulsen's remarks can be found in the Board materials.

4. FINANCE AND GENERAL BUSINESS

Finance Report

Ms. Harris stated that tax revenue through October 31 was \$8,464,015. This is \$469,485 (5.26%) below forecast and \$665,897 (7.3%) less than the same period in 2022. Interest revenue through October was \$399,048 which is \$50,248 above forecast. This is the result of increases in interest rates since the beginning of the year. She stated that expenditures for non-grant expenses through October were \$797,108 and are tracking \$70,320 below budget, primarily due to timing of payments.

Trustee Sherman asked how much money was in the bank. Ms. Harris replied that there is approximately \$12 million in the bank and \$815,000 outstanding as a receivable. Trustee Sherman asked how much money would be unencumbered at the end of December. Ms. Harris said approximately \$1.9 million, as shown on page 13 of the Board packet. Ms. Harris added that those funds will be used to ensure CAC could provide the same grant award amounts to General Operating Support and Cultural Heritage recipients in 2025.

Approval of 2024 Board Meeting Schedule

Trustee Mendez stated that the 2024 Board meeting schedule was included in the packet for the Board's approval.

Motion by Trustee Scott Taylor, seconded by Trustee Blakemore, to approve the 2024 Board meeting schedule.

Discussion: Trustee Sherman stated that she could not attend a meeting on February 21 and asked that the meeting be moved to February 13 or 15. It was agreed a new date would be found for the February meeting.

5. **BOARD ACTION**

Mr. Sinatra, CAC director of grantmaking strategy and communications, provided an overview of the 2024 grant application and panel review process, including the recommendations for 2024 grantmaking totaling \$10,750,487 for 300 organizations. Mr. Sinatra provided summary comments which were included in the grants memo in the Board materials, provided to the Board in advance of the meeting.

Director Paulsen provided an update to the Board on the status of The Cleveland Ballet. Trustee Isenhart requested that the grant to The Cleveland Ballet be approved separately with additional conditions.

Ms. Isenhart asked that the criteria for grantmaking be reiterated. Mr. Sinatra reviewed the scoring criteria (public benefit, artistic and cultural vibrancy, and organizational capacity), as well as the score needed to be recommended for funding (Included in program guidelines).

Approval of General Operating Support 2024 Grant Amounts

Mr. Sinatra presented the Board with the slate of 2024 General Operating Support grantees and highlighted 73 organizations recommended for funding.

The following actions were taken:

Motion by Trustee Scott Taylor, seconded by Trustee Mendez, to approve the 2024 General Operating Support grants (below).

Discussion: Trustee Sherman stated that she thinks that all grants should be made at this November meeting and CAC administrative budget should also be provided and approved at this time. Everything should be done at one time.

Trustee Sherman motioned to delay approval of grants to December. There was no second to the motion.

Trustee Sherman motioned to increase the funding pool by \$1million to restore grants to their base level. There was no second to the motion.

Trustee Sherman motioned to take increases from some grantees that are recommended for larger grants and to give that money to grantees receiving decreased grants. There was no second to the motion.

Executive Director's Report

Regular Meeting of the Board of Trustees: December 13, 2023

Welcome to our December meeting.

Today CAC's Board will have the opportunity to approve three grants.

- Two Resident-Led community art grants: ioby and Neighborhood Connections.
- One Support for Artists grant: Assembly for the Arts

These three grants round out CAC's 2024 grant commitments.

In addition, the Board will conduct regular administrative matters, including the approval of minutes, contracts, and the 2024 organizational budget, of which approximately 92% goes directly to grants.

Additional items of note:

- Our recommendation that Assembly design and manage 2024 Support for Artist funding comes, in part, from the community engagement and planning project Assembly conducted this fall. CAC is acting on what we heard. Looking forward, we know the work will require accountability and space for learning from the past. The work will also require true partnership between Assembly and CAC to 'expand the pie' of resources for artists from additional sources. We believe that CAC and Assembly must work together to move forward both for this project and for the success of any future levy efforts.
- The Education Foundation of America, via The Cleveland Foundation, has awarded CAC \$41,000 in operating support for 2024. These funds will be used to offset operational costs and a modest expansion of efforts to highlight and promote CAC-funded arts events to the residents of Cuyahoga County.
- Finally, I call your attention to the Staff Report in this packet, which highlights the team's 2023 work. I remain grateful for my teammates' positivity and willingness to go above and beyond to serve our grant applicants and recipients. Thank you.

2023 in Review: Updates from CAC Staff

December 13, 2023

CAC's work is rooted in our <u>10-year community planning process</u> that identifies the two constituents that we must serve as: 1) nonprofit arts organizations; and 2) the residents of Cuyahoga County. Every year, staff creates a <u>work plan</u> that is grounded in this framework and CAC's <u>Mission</u>, <u>Vision & Values</u>.

What follows is a summary of key 2023 staff work.

1. GRANTMAKING: Connecting with and serving nonprofit organizations.

CAC provided high quality assistance to hundreds of arts and culture nonprofits in 2023. CAC staff managed processes and supported grantees as they closed out 2022 grants, carried out 2023 grants, and applied for 2024 grants. To successfully administer these grant cycles, CAC managed a portfolio of 273 current grant recipients in our core grantmaking, offering personalized customer service.

2023 Core Grantmaking Summary:

As outlined in the Board-approved guidelines, CAC launched and administered the application processes for 2024-25 General Operating Support, 2024-25 Cultural Heritage, and 2024 Project Support. CAC's grantmaking team designed, built, and managed three grant application processes, including eligibility checks, full applications, panels, reporting, and grant contracts. New in 2023, staff built an additional process by which Project Support grantees could bypass the full application and panel processes. A snapshot of key activities throughout the process follows:

Grant Guidelines

Each year, CAC solicits and responds to formal and informal feedback from applicants and grant recipients to inform the grant guidelines, application, and panel process.

- CAC offered a public comment period on draft guidelines via CAC's website.
- All applicants were surveyed for feedback on the eligibility check, application, and panel processes.
- CAC hosted technical assistance opportunities for applicants and took feedback during those sessions and hosted conversations on its process and grant opportunities at Arts and Culture Network Nights.
- Throughout the year, CAC was responsive to ongoing calls and emails from applicants, grant recipients, and those interested in the process but have never applied.
- CAC met with staff at Assembly for the Arts to gather feedback on our grant guidelines.

Following the feedback period and CAC Board of Trustees approval in April 2023, CAC finalized, designed, and published the guidelines, sharing widely. Staff also implemented changes to streamline and simplify the application and panel process, and to provide stability and implement multi-year funding commitments.

Workshops & Technical Assistance

CAC provides a variety of technical assistance opportunities to ensure applicants have the tools and information to be successful in the process. To ensure every applicant gets the help they need, the team recorded many online workshops and made them available on CAC's YouTube channel. CAC staff provided a significant amount of technical assistance one-on-one via phone and email. This year, those offerings included:

- Three grant recipient workshops, attended by 204 grantees, including all new 2023 grant recipients. To ensure their success during the grant period, topics covered included crediting and reporting requirements, payment requests and connecting with their grant manager.
- CAC hosted multiple, informative workshops and Q&A sessions covering every step of the application process, funding criteria and changes to the application. Participation in all these sessions totaled more than 180, with some participants attending multiple offerings:
 - Grant opportunities workshop (108 participants)
 - Application workshops for the GOS, CH and PS programs (32 participants)
 - Workshop with Plante Moran on 990 and 990EZ (17 participants)
 - SMU | DataArts Cultural Data Profile workshop (26 participants)
 - Two rounds of virtual office hours where applicants met with staff to address specific questions.
- CAC regularly connected with all grant recipients through technical assistance calls, report
 feedback meetings, and site visits, to help them maximize their grants while navigating the
 continued pandemic and informing our work.
- Continued to offer "CAC Top Three," a newsletter for our grant recipients (12 issues sent in 2023 to more than 1,000 individuals each month), that responds to the interest of the groups we fund and connects them to resources. This newsletter continues to receive higher than average open rates.

Eligibility Check & Application

To facilitate a streamlined application process, staff built online application forms in alignment with the Board-approved grant guidelines for General Operating Support, Project Support and Cultural Heritage. This includes multistep online processes by which applicants can verify their eligibility to apply for or continue to receive CAC funding, upload documentation and complete application requirements. This year, CAC staff:

- Processed and verified eligibility checks for 347 nonprofit organizations.
- Communication: conducted outreach, technical assistance, and reminders through dozens of email communications and personalized outreach
- Reviewed and processed applications from 305 nonprofit organizations, verifying eligibility for panel or bypass/steady cohort.

Project Support Bypass Option – New in 2023

- Processed and verified eligibility for 126 CAC grantees, so that they could bypass the application and panel processes.
- Developed communications plans to support the launch of this new option, including technical assistance, guides, and online forms.
- Collected and processed 126 "Project Info Forms" to collect required information to make 2024 grant recommendations.

Panel

To review and recommend grants in a transparent and impartial manner, CAC staff recruited a diverse roster of panelists from around the country. Staff trained panelists in the review process and funding criteria. For the live and written panels, staff chaired the proceedings, provided technical support to panelists, shared progress on social media. Staff worked to prioritize panelist diversity across age, race, gender, and discipline.

- Recruited and vetted 29 panelists through personalized outreach and interviews.
- Hosted live panel meetings in September, attended by dozens of grantees and the public.

Contracts, Reporting, and Payments

To help ensure grantee success and foster trust-based philanthropy, staff ensured grant compliance through our contracts, reporting and payment processes. In 2023, CAC managed nearly 300 contracts, approved more than 400 reports, and issued 424 separate payments to grantees. CAC also:

- Managed more than 275 grant contracts, including gathering signatory contact information, updating database, issuing agreements, and following-up on timely return of signed contracts.
- Reviewed all reporting requirements in General Operating Support, Project Support, and Cultural Heritage, streamlining or eliminating requirements where possible.
 - Reviewed and provided feedback as needed for annual goals and mid-year reports by 80 Cultural Heritage and General Operating Support grantees.
 - Conducted 12 mid-year meetings with all Cultural Heritage grant recipients.
 - Reviewed annual goals and interim reports for 5 Support for Artist grantees.
 - Reviewed and approved 252 final grant reports, providing feedback on each.
- Hosted four virtual report-outs for Project Support grantees with grants up to \$5,000. These events continue to be a well-attended alternative to the written report format and provide connections with and support from peer organizations.
- Reviewed and approved 66 advance payments for Project Support grantees, ensuring organizations had access to funding up front to start their public projects.
- In total, reviewed related documents and released 424 separate payments to grantees.
- Held site visits or conducted additional outreach for grantees as needed.

Resident-Led Grantmaking

CAC continued supporting resident-led projects through grants to Neighborhood Connections and ioby.

- Since 2013, CAC has co-funded over 454 resident-led arts and culture projects with Neighborhood Connections. In 2023, our \$50,000 investment helped co-fund 34 neighborhood arts and culture-based projects responding to groups of residents who organize projects that offer creative solutions to challenges in their neighborhoods. Successful applicants received grants of up to \$5,000.
- CAC completed its 5th year of the <u>ioby</u> Cuyahoga Arts & Culture Match Fund. The fund provided up to \$3,000 per project in match funds, totaling \$83,350 in resident-led arts projects. CAC funds helped residents raise an additional \$98,625 on ioby.org, for a total of \$181,975 directed to 50 local arts and culture projects. This includes a 19% increase in the number of projects supported compared to the previous year of this partnership.

To continue this successful work, CAC will bring before the Board at its December meeting a recommendation to continue its resident-led arts and culture grantmaking through ioby and Neighborhood Connections. See the Resident-Led Grantmaking memo in this packet for more details.

Support for Artists

Throughout 2023, Cuyahoga Arts & Culture funded four nonprofits to provide a range of support and funding opportunities for Cuyahoga County artists. Grants to Assembly for the Arts, Julia de Burgos Cultural Arts Center, SPACES and Karamu House supported more than 50 Cuyahoga County artists in 2023. These grants provided fellowships, project-based funding, access to physical spaces to create and display artworks, professional development, relationship-building and collaboration between artists and nonprofit organizations, and more.

To continue this commitment, CAC will bring before the Board at its December meeting a recommendation to make a grant to Assembly for the Arts to conduct 2024 Support for Artist work. See the 2024 Support for Artists memo in this packet for more details.

2. COMMUNICATIONS: Connecting with residents and promoting CAC-funded events.

2022-2023 Report to the Community. In June, CAC released its annual report in a digital and mailed print format. The report summarizes the resilience of grantees and impact of CAC funding during the continued pandemic. The report has been viewed by hundreds of grantees, public officials, and other engaged residents. View and share the report at https://2022report.cacgrants.org/.

Highlighted the Work of CAC Grantees. FreshWater Cleveland did six features that raised awareness of CAC's grant recipients. Each piece shared a unique perspective on CAC-funded activities. These stories received thousands of views through FreshWater Cleveland's website and social media pages.

In addition, WKYC Channel 3 did five TV segments highlighting the work of CAC grantees and promoting the ClevelandArtsEvents.com website. The stories reached thousands of people through wkyc.com and Facebook advertising.

Launched new cacgrants.org and ClevelandArtsEvents.com websites. In August, CAC launched two newly designed websites to better serve the community. CAC's website launched with a new design and navigation. ClevelandArtsEvents.com was redesigned in partnership with Assembly for the Arts and is now maintained collaboratively.

In 2023, the ClevelandArtsEvents.com website continued to see more than 5,800 users per month, who view more than 14,000 pages each month. 2,413 events were posted on the website this year, which yielded 84,532 site visits.

Also, of note, the most visited page on the ClevelandArtsEvents.com website continues to be the "jobs" section listing job postings, calls for artists, and other opportunities for artists and creatives. This page alone saw more than 11,000 views in 2023. CAC also maintained strong participation on its social platforms:

Gathered the Arts & Cultural Community. Working with Neighborhood Connections and Assembly for the Arts, CAC offered opportunities to convene our grant recipients, artists, and residents. In 2023, Neighborhood Connections hosted five in-person Arts & Culture Network Nights. These events were attended by representatives from CAC-funded organizations, artists and residents engaged in the arts & cultural community. The goal of these events is to spark connection and inspire collective action among our arts and cultural community. Each Network Night and Community of Practice was attended by 20-50 participants and fostered conversations and connections. In 2024, we will once again co-host these events with Assembly for the Arts.

Media Placements. Cuyahoga Arts & Culture continues to see steady and broad-reaching traditional media coverage in print, radio, and on broadcast media. In addition to consistent crediting of Cuyahoga Arts & Culture in the media by our partners, below are a sampling of the media placements focused on or mentioning CAC's work or support in 2023, that contributed to continued awareness of CAC:

3. Effective TEAMWORK and OPERATIONS

- Received the Auditor of State Award. Once again, CAC received the highest opinion that the
 Auditor of State gives: no findings and no material weaknesses for our 2022 financial audit, which
 led to CAC once again receiving the Auditor of State Award, an award received by fewer than 5%
 of public agencies in Ohio.
- Set and Measured Goals. All CAC staff members tracked progress against their personal professional development plans each quarter, concentrating on ways to work smarter, not just harder, resulting in a team that stayed focused on key objectives.
- Continued Participation in Government Alliance on Race & Equity (GARE). Staff participated regularly in GARE's Arts & Culture Working Group and used discussion boards and resources to connect with public sector peers throughout the country and inform our work.
- Maintained a Commitment to Learning and Action, with a Focus on Racial Equity. CAC's
 Core Racial Equity Working Group continued its support of internal learning and action within the
 organization.
- Staff Updates.
 - o Welcomed Maya Curtis and Dayvon Nichols, CAC grants managers.

FINANCIAL UPDATE

2023 YTD

Revenue. Tax revenue through November 30 was \$9,166,573. This is \$686,927 (7%) below budget year-to-date and \$917,406 (9.1%) below revenue for the same period in 2022. Interest revenue through November was \$429,756 which is 53,365 (14.2%) above forecast.

As of November 30, CAC investments:

- RedTree Investment Group: \$11,248,747 (target yield 3.7%)
- STAR Ohio: \$1,925,345 (yield 5.59%)

Expenditure. Non-grant expenditures through November were \$871,243 and are tracking under budget by \$54,661 due to timing of payments.

2023 Year End Outlook

Revenue is expected to be approximately \$700,000 lower than forecast at year end, pending tax receipts for December. Expenses for 2023 will be slightly below budget primarily due to reductions in grant payments and modest lower-than-budgeted expenses. In addition to monthly tax and interest revenue, CAC has used \$2.9 million from its general fund to issue grant payments and for operational expenditures. The approved 2023 budget indicated \$2.3 million would be used from the general fund. The additional draw is due to the shortfall in tax revenue (~\$700k) which was partially made up by higher interest revenue and lower overall expenses. It is estimated that CAC will begin 2024 with \$1.6 million of unencumbered general funds, which will be used to keep 2025 General Operating Support and Cultural Heritage grants the same amount as the 2024 grants.

Re: 2024 Resident-Led Grantmaking

Board Action: Cuyahoga Arts & Culture recommends grants to two nonprofit organizations, totaling \$160,500, to provide grants for responsive, resident-led work in 2024. These organizations are Neighborhood Connections (\$60,500) and ioby (\$100,000).

CAC's Commitment to Resident-Led Grantmaking

Through its resident-led grantmaking, CAC supports emerging community-based and neighborhood projects across Cuyahoga County. Since 2013, CAC has co-funded over **454 resident-led arts and culture projects** in Cleveland and East Cleveland and invested a total of \$847,485 through Neighborhood Connections grants and Arts & Culture Network Nights. Since 2019, CAC has invested \$368,350 in matching funds into **169 resident-led arts and culture projects** through the ioby-CAC Match Fund. See the Staff Report for more on the impact of 2023 Resident-Led grants.

Neighborhood Connections: \$60,500 to co-fund resident-led projects in Cleveland and East Cleveland and host four in-person gatherings for artists, arts & culture organizations, and residents in 2023, alongside Assembly for the Arts. Neighbors work together to propose creative, arts and culture-based solutions to challenges their communities. Applicants are eligible for grants of up to \$5,000, with CAC matching up to 50% of the award. Neighborhood Connections makes grant selections by a committee of residents throughout the year, providing responsive grassroots grantmaking.

ioby: \$100,000 for the Cuyahoga Arts & Culture Match Fund to support resident-led arts and culture projects in Cuyahoga County in 2024. Ioby leverages CAC funding through a 1:1 match from citizen philanthropy. \$80,000 in match funds from CAC will generate an additional \$80,000 in funds raised through crowdfunding on ioby.org, for a total of at least \$160,000 supporting local arts and culture projects. An estimated 30-45 projects will receive up to \$3,000 in match funds in 2024. Participants will be trained in crowdfunding best practices, building fundraising competence and confidence for the long term, while investing in their own communities.

Next Steps

Following Board approval, CAC staff will work with Neighborhood Connections and ioby to launch and copromote these grants to potential applicants in 2024.

Re: 2024 Support for Artists grant

Board Action: Approve a grant of \$400,000 to Assembly for the Arts for them to design and manage 2024 Support for Artist program that results in funding and support programs for Cuyahoga County artists, as well as the establishment an artist advisory group to advise Assembly on its future work.

Background

In April 2023, CAC made a community engagement and planning grant to Assembly to design and hold open and inclusive engagement activities for artists and residents over 4-5 months. The grant was to result in 2024 Support for Artists Plan (the proposal that follows this memo) that identifies how Assembly will invest \$400,000 in artist support opportunities that: 1) center equity; and 2) recognize and address the diverse needs of Cuyahoga County-based artists.

CAC and Assembly agreed that Assembly's successful Support for Artists 2024 (SFA24) Plan must:

- be the result of *engagement of hundreds of people* (artists, creatives, culture bearers, residents more broadly), representing the full diversity of our county.
- prioritize funding and resources for historically underrepresented or marginalized artists.
- continue to *address the five distinct needs* of artists identified by CAC's support for artists planning team in 2017 (flexible funds, project funding, access to space, institutional connections, and professional development).
- consider, as the option or as part of a broader plan, *regranting to proven CAC-funded artist service providers* (*local arts nonprofits*) who have deep knowledge of community and expertise in delivering equitable artist support programs.
- include approaches that could be expanded with additional funding sources (beyond CAC).
- result in a *standing ongoing artist advisory group*, housed at Assembly, that informs and assesses all of Assembly's artist programs and services, inclusive of SFA24.

About the Proposed SFA24 Plan

Assembly outlined plans for how it intends to spend \$400,000 to serve Cuyahoga County artists in 2024; their grant proposal follows this memo. Their proposal is based, in part, on recommendations resulting from CAC-funded community engagement and listening grant. The plan includes working with regranting partners who have previously received Support for Artists funding from CAC, including Assembly itself, who will carry out its own artist funding and support programs. Their plan also includes potentially offering:

- larger grants to fewer artists in 2024;
- an emphasis on unrestricted, fellowship-type funding for artists;
- expanded funding opportunities for artists, including sponsorship-type funding through Assembly.

Additionally, Assembly will continue artist listening efforts in 2024 that will lead to the launch an artist advisory group to help inform their implementation of this grant and broader efforts.

Next Steps

Pending Board approval, CAC will issue a grant \$400,000 to Assembly for them to design and manage a Support for Artists program in 2024.

Recommendations

- Scenario #4 will allow Assembly and other regranting organizations to give artists larger awards.
 - Each organization will be able to award 6 to 8 grants of \$8,000 each (= \$49,000/\$8,000 or \$70,000/\$8,000), depending on whether there is additional foundation support to cover administrative costs of operating programs. This is considering the following recommendations:
 - Increase the amount of each grant/award (\$8,000+) and if the award is tied to a project, make a substantial amount unrestricted (50-70%)
 - Collectively solicit funding from Gund or Cleveland Foundation to cover administrative costs or dollar match funds (split cost with organizations)

ACTION: At the December 13 board meeting, Trustees will be asked to approve the 2024 annual budget for CAC in the amount of \$12,390,000.

Background

CAC creates its budget annually based on what we plan to accomplish during the next fiscal year. Our budget is a representation of already-approved grant awards for 2024, organizational values, and anticipated revenue declines.

2024 Budget and Annual Objectives

Overall, this annual budget ensures that CAC is positioned to achieve its 2024 organizational and team objectives, while limiting expenses wherever possible. This includes:

- Effectively managing an organizational portfolio of more than 300 grants throughout 2024.
- Centering equity in our daily work and long-term strategy.
- Connecting more residents to CAC-funded arts and culture events and raising awareness of how the investment of CAC funds improve their lives.
- Investing appropriately in staff to retain our strong team.

Revenue

The excise tax revenue projection for 2024 is \$9,203,750. This projection is based on a three-year rolling average of the decrease in tax receipts seen over the past three years – approximately 7.5% (2021/2020, 2022/2021 and 2023/2022). Interest revenue is forecast to be \$450,000, net of investment fees, based on projections provided by our investment advisor.

Expenses

Anticipated 2024 expenses, detailed below, will be approximately \$12,390,000. More than 85% of the expenses are committed to grants to 300 nonprofit organizations, approved by the Board at the November 15, 2023 meeting. To meet the commitments approved by the Board, CAC uses its general fund to issue contracts in advance of the next fiscal year (2024), to meet statutory requirements, and for cash flow needs. As such, CAC will use an estimated \$2,695,250 of the general fund to support the FY24 budget. Using the general fund is an intentional part of CAC's long-range budgeting and expenditure model. This approach allows the agency to provide predictable funding over multi-year periods, with adjustments typically every two to three years, to address the cumulative effect of annual decreases in tax revenue.

Appropriation Detail

1. Grants and Grants Management

a. Salaries, Wages and Benefits: \$409,288

This category includes salaries for the director of grantmaking strategy and communications (75%), three grants managers (100%), grantmaking & communications associate (75%) and director of administration (25%). Benefits include health, dental and vision insurance, and contributions, as required by law, to Medicare, Bureau of Workers Compensation, and the Ohio Public Employee Retirement System. Note: this category's increase is primarily related to CAC having open positions in 2022 and early 2023 which are now filled.

b. Grantmaking Management: \$71,450

The expenditures in this area are comprised of three broad categories: application and panel review activities; grantmaking management, technical assistance for grant applicants and recipients; and marketing and promotion of CAC-funded arts and culture organizations and events to the residents of Cuyahoga County through ClevelandArtsEvents.com. In 2024 CAC will increase its outreach to grantees and their stakeholders to highlight the benefit of our county's tax for arts and culture. These additional education activities are supported through a grant from the Educational Foundation of America (EFA).

c. Grants: \$11,325,487

This category represents grants awarded through: General Operating Support (\$9.18mil.); Project Support and Cultural Heritage (\$1.57mil.) grant programs; Neighborhood Connections for grassroots grantmaking and convening (\$60.5k); ioby for crowd-funded grants (\$100k); SMU DataArts for use of the Cultural Data Project (\$14.5k); and the Support for Artists grant to Assembly for the Arts (\$400k).

2. General and Administrative

a. Salaries, Wages and Benefits: \$374,075

G&A staff salaries include the executive director, 25% director of grantmaking strategy and communications, 25% grantmaking & communications associate and 75% director of administration. Benefits include health, dental and vision insurance, and contributions, as required by law, to Medicare, Bureau of Workers Compensation, and the Ohio Public Employee Retirement System.

b. Facilities, Supplies, Equipment: \$64,427

This category includes expenses for rent, utilities, office supplies, printing, postage, computer software and other business machines.

c. Professional Fees: \$145,273

This category includes fees for banking, legal, communications/strategy, IT support, visual identity, accounting, and financial services.

Note: OPERS is requesting the employer match be increased from 14% to 18%. It is unknown if this change will be made and if it is, whether it will take place during CAC's fiscal year.

Action Requested

We ask that Trustees approve the 2024 annual budget in the amount of \$12,390,000. We look forward to answering your questions at the December 13 Board meeting.
