At this interactive workshop presented by Equius Group, explore components of CAC's 2024 funding criteria. Applicants and grantees across all CAC grant programs will explore the "both/and" mindset, and the REDEI (Racial Equity, Diversity, Equity, and Inclusion) conscious approach to work toward being accessible and inviting both its community, and the broader public. This workshop will include a specific case study of a peer organization, as well as actionable ideas to implement as you plan your programming or CAC grant application. CAC requires a SMU DataArts Funder Report to be generated and uploaded as a required support material for the following grant applications: General Operating Support (FY20, FY21, and FY22), Cultural Heritage (FY21 and FY22) and Project Support (two most recently completed fiscal years – required for organizations applying for grants of more than \$5,000). We recommend starting this well before the application deadline and offer this workshop to support you in this process.

Attendees will learn how to participate in SMU DataArts' online platform for data collection, produce reports, and gain insights into the cultural sector. This session includes the basics of how to complete the Cultural Data Profile (CDP), how to apply to participating grantmakers using the system, and how to access DataArts' free analytics and educational opportunities. This session is ideal for users new to the Cultural Data Profile.
